Monitoring of Research

The faculty members of NIEPA are active researchers who conduct research from time to time, in order to improve the education system and contribute to the field of knowledge.

The Project Management Unit (PMU) was constituted in NIEPA on 2nd Feb, 2014 with the agenda of supporting in-house and sponsored research. PMU provides administrative support for managing the undertaken projects. It undertakes three major responsibilities: Managing projects, handling funding and accounting of the projects, and recruitment of the required project staff.

PMU has devised a proper structure to bring forth qualitative research work that is productive and valuable. Therefore, the following mechanism is used to monitor the whole research process:

1. RESEARCH PROPOSAL- Submission after approval of DAC

The research proposals are developed by the faculty members of NIEPA on dynamic themes and sent for approval. The researcher clarifies the study details, duration of the study, the estimated budget required, staff/ human resources required, etc. The Competent authority examines, approves and then the Academic council endorses the research study. Every step is channelized and formal notifications are used to notify the researchers and concerned authorities. In the past years, a number of research proposals have been submitted and approved by the competent authority. Also, the further monitoring process for the research work is clarified to the researcher.

2. EXTERNAL EXPERT REVIEW

Quality of research work has to be maintained throughout the process therefore, external experts are nominated by the Vice-Chancellor and invited to review the research proposals. Eminent experts such as Prof. Mohammad Miyan, Prof. Vimala Ramchandran, Prof. D V L N Somayajulu, Prof. M. M. Pant, Prof. Sachidanand Sinha, etc. from across the country have reviewed the research proposals approved by the Competent authority of NIEPA. The external experts deeply focus on the context and rationale of the proposed study, research questions, specific objectives of the study, study design, methodology, sampling frame, data analysis framework, the timeline of implementation, and budget.

3. RESEARCH PROGRESS MONITORING

The research progress is monitored through a Quarterly progress report presented by the researcher at regular intervals of time. The PMU at NIEPA notifies the faculty members to provide Quarterly Progress Report of their completed or ongoing research projects. These reports are discussed in the faculty meetings with the Vice-Chancellor. These meetings keep the proposed time duration of the study on track and also provide valuable feedback to the researcher during the meetings.

4. INTERNAL REVIEW OF RESEARCH REPORT SUBMITTED

The Internal Research review committee is set by the institution consisting of a chairman and some members. The committee exhaustively goes through the research work done by the faculty members in different areas and themes. The committee provides its suggestions and provides details of fine areas that need revision and to which the changes should be done.


1. The concept and methodology of participatory action research may be elaborated and may also be included as a separate chapter. The term participation could be operationally defined.

4. Findings of the study may be analysed in light of the existing literature.







The Committee after having gone through the research report exhaustively has made the following recommendations:

1. The report requires one additional chapter in the beginning to strengthen the Literature Review. The review may include a discussion on: growth of Privatisation and its impact, challenges posed as a result of the development of a separate Private Universities Act, interactions between the State and the Universities system in light of rapid privatisation and an expansion of higher education mostly through the private sector, a comparative review of Public University Act and Private University Act etc. The chapter should end by giving the proper theoretical frame for the study against which, the analysis should follow.
2. The analysis on the relationship between the Private University Act and fee regulation should be strengthened. It is suggested that an additional chapter may be included based on 6 models of fee fixation as identified by the author (on page no. 30, table 3.5). A comparative analysis of the relationship between the individual University Act and their fee fixation models to highlight the critical elements vis-à-vis their implementation and challenges may become the main body of the chapter.



3. It would be good if the author can insert a table in Chapter-6, highlighting 03 aspects in a comparative frame:-
 - (Column 1) Provisions in the Universities Act.
 - (Column 2) Actual practice against the provision.
 - (Column 3) Remarks where diversions exist between the two.
4. In the final chapter, recommendation should follow from the analysis of issues/challenges done within the theoretical frame of the study.
5. There is a need to keep confidentiality of the institutions since some of the discussions point to various negative features being followed in the private universities.
6. Many of the statements need referencing or footnotes. The report needs a close reading for the sources of statements and its implications. Along with corroborating the statements with proper references, the report requires a thorough editing.

At the outset the Chairman welcomed all the members and thereafter took up the research reports one by one. The Committee Members, after having gone through the research reports exhaustively, have made the following recommendations regarding each report, successively.

1. A Critical Assessment of State Level Capacity Building Institution in Education

- The report should be re-organized systematically addressing the broad themes related with the title conceptually; it should have a sound conceptual framework and the context, followed by analysis and results.

- A separate chapter should be devoted to 'review of literature' identifying knowledge gaps and the need for filling those gaps with new research findings. The literature review provided in the report is quite limited.
 - The 'Introduction' chapter should have rationale and justification; and besides presenting capacity building institutions landscape in India as the context, it may also introduce the structure of the report. The author should revise the chapters on SCERT and SIEMAT in the light of evaluation objectives specified
 - Methodology may be detailed out in terms of the tools used for data collection and in the context of number of questionnaire or survey used to collect the data.
 - The style of writing should be analytical, justifying 'Critical Assessment' nature of research. The discussions may include an analysis of regional variations in working conditions and financial resources available for functioning of the capacity building institutions. The given data need more justification and the report requires an additional chapter on discussion and findings.
 - Tables and texts should be aligned in terms of analysis and writing. Large tables may be shifted to Annexure and the References should follow uniform style as per NIEPA guideline.
- 2. A Study on Policy and Practices for inclusion of Children with Specific Learning Disability in Selected Schools**
- Introduction chapter should begin with a focus on inclusion of children with special needs instead of quality of education. The structure of the report describing the scheme of the chapters to follow may also be incorporated in the Introduction.
 - The logical sequence of themes in the existing report is not clear. It is suggested that the chapters need to be reorganized in order to fulfil the objectives with the help of content analysis and conceptual framework. The author should provide data properly integrated with the discussion and findings.
 - The Literature Review should focus on policy and practices for inclusion of children with disability. For a clear picture on the state of existing knowledge

and identification of the knowledge gap, the review requires analysis and a critical evaluation.

- Following the logic of macro to micro, SLD should be discussed sequentially beginning with global, national and sub-national levels, on the basis of their status and issues.
- The methodological details do not make it clear how both qualitative and quantitative data have been collected and analysed; they should be specified properly. The author may give the table to present the number of Qualitative and Quantitative tools which has been used to collect the data.
- Discussion, Analysis and Research Findings need to be presented systematically under separate headings and sub-headings.
- The report does not have 'Conclusion' chapter. The findings of the study should be brought out properly under the Conclusion chapter, leading to their linkage with the Recommendations. The report is sketchy and needs to have analytical rigour in terms of its contribution to the existing body of knowledge.
- References should follow uniform style as per NIEPA guidelines.

3. Financing of Higher Education: Institutional Responses to Decline in Public Funding

- The concept of new-liberalism and on-going discourse on its impact on higher education sector should be explained properly, to be followed by analysis of the funding and financing of higher education.
- Accordingly introductory paragraph needs to be reframed in the direction to highlight the influx of neo-liberal market principles on funding in financing and how they are impacting the quality, employability and other factors.
- On page number 3, point 1.2, why Public Financing of Higher Education Sector needs sufficient justification?
- Maximum tables given by author do not connect properly with objectives. It needs justification and focus on important issues instead of other things. It appears vague and should be structured and organized.


- The author needs to justify table numbers 5.3, 5.4, 5.5, 5.6, 5.7 and 5.8 that how they are important and linked to budgetary problems.
- According to the title, the author needs to justify what are the responses of institutions on decline of public funding, link the conceptual framework which is given on page number 107; and literature review should be based on that.
- In the report, the author has given both figures and tables of the same data. It is felt that there is no need to use both of them. Either of the two may be used.
- What were the key findings that emerged in different universities? Need comparative analysis across the universities (both state and central funded university). Comparative analysis overall needs more strengthening.
- The key issues faced across the universities may be highlighted.
- Content page needs to be restructured to provide section-wise details.


7.1 Considering confirmation of the Minutes of the 6th meeting of Internal Research Review Committee held on 06-08-2021

As discussed, and decided in earlier meetings, the concerned faculty/Pis will submit the outcome of the

study in the format of the Occasional paper for dissemination, especially when it is not being published in a book form, the PI may be asked to submit for the publication as Occasional Paper

7.7 Considering final report of the study on "Decision Making Process at the DEO office in Faridabad district in the state of Haryana: A Pilot Study" submitted by Prof. Vineeta Sirohi

The Committee was informed about the submission of the Report of the above-mentioned Pilot Study. The PI desired that the outcome of the study may be disseminated in the NIEPA Occasional Paper. The Committee noted the information and request. The Committee also unanimously agreed that since the PI has desired to have this pilot study published as an occasional paper, which is examined by the concerned editor and further reviewed by the expert, there is no need on the part of IIRC to review the pilot study at this stage.

7.8. Considering review of the revised report of the research study titled "Governance and Management of Higher Education Institutions in India" submitted by Dr. Garima Malik

Alike other revised reports, the Committee assigned the work of review to Prof. Kumar Suresh and Prof. Vineeta Sirohi. Subsequent to the report of the said reviewers the research study shall be deemed as completed.

7.9. Considering Revised Research Proposal on "Governance, Management and Leadership for Quality Early Childhood Education across Odisha, Punjab and Kerala" submitted by Prof. Rashmita Das Swain

After due deliberations, the Committee observed that the aforesaid research proposal was sent to this Committee only for preliminary review and not for the expert review, which has already been done by this Committee. Now the said research proposal (revised in consonance with the suggestions given by the IIRC) may be sent only for the academic review by the external experts. It was felt by the Committee that in the absence of any specific guidelines regarding the review of the budget portion of the fresh research proposals, it will be difficult for this Committee to review the budget portion and offer any comments or suggestions.

7.10 Considering revised Research Report on the study entitled "Participatory Action Research for improving the Participation of Children in elementary Schools in India" submitted by Prof. Madhumita Bandhopadhyay

The Internal Research Review Committee had recommended that the study shall be reviewed by Dr. Nidhi and Prof A.K. Singh before the same is forwarded to the external experts. The study shall be deemed as completed after the report received from the aforesaid reviewers.

7.11 Considering new Research Proposal on "Inter-linkages of Social Capital and School Education in India: An Interstate Comparative Study" submitted by Prof. Madhumita Bandhopadhyay

Detailed discussions were held regarding the aforesaid research proposal submitted by Prof. Madhumita Bandhopadhyay. It was decided that since the said proposal has already been presented in the Departmental Advisory Committee, the IIRC shall only look into the basic format of the proposal before it is sent to the external experts for academic review of the research proposal. The Committee was of the view that in the absence of any specific guidelines regarding the review of the budget portion of the fresh research proposals, it will be difficult for this Committee to review the budget portion and offer any comments or suggestions. The budget allocation part may be examined separately before its final approval.

It was decided that the basic format of the research proposal shall be looked into by Dr. Nidhi S. Sabharwal in consultant with Prof. A.K. Singh. The proposal will return after their comments and suggestions, if any.

7.12 Any other agenda with the permission of the Chair:-

Review of the revised research report submitted by Dr. Savita Kaushal

As has been mentioned above (under agenda item No. 7.2.) the Committee in its previous meetings held at different points of time gave certain suggestions to some specific PIs including Dr. Savita Kausal for revision of their reports, but the revised reports were not received and hence the same was reported to the Committee in its current meeting. However, Dr. Savita Kausal had submitted the revised report of her study titled "A Study of Private Franchise Providing Pre-School Education in Delhi" after finalization and printing of the agenda for the current meeting, hence it was discussed as the last agenda item after due permission of the chair. Accordingly, as has been decided in other similar cases, the revised report shall be reviewed by Prof. Vineeta Sirohi to verify that all the suggestions given by the Committee in its earlier meeting(s) have been incorporated.

With respect to examining whether the Comments and suggestions provided by the members of the IIRC on various research reports have been incorporated by the authors in their revised research reports, it was suggested that:


- a) The authors of the research reports may highlight and provide details on where and how the peer-review feedback has been incorporated in the revisions of the research reports.


Handwritten signatures and initials are present at the bottom of the page, including a large signature that appears to be 'Vineeta Sirohi' and several smaller initials.

- b) In order to expedite the process of reviewing the revised reports, it was suggested that comments and feedback made by the members of the IRRC should be shared with all the members by the team PMU.




The meeting ended with a vote of thanks to the Chair, all other members and Team PMU for providing assistance to the IIRC.
