Agenda item No.21.3.1 Appointment of Vice-Chancellor

The Registrar (I/c) Prof. Zaidi briefed the Council that in pursuance of Order No.18-/2015-PN.I dated 7th December, 2017 received from MHRD, Prof. N.V. Varghese assumed the charge of the post of Vice-Chancellor (NIEPA) w.e.f. 07/12/2017 (F/N).

Agenda item No. 21.3.4 Amendment to the Memorandum of Association (MOA) and Rules of NIEPA

The Chairman of the Committee, Prof. Sudhanshu Bhushan, briefed the Council that the Committee constituted for the purpose has had two meetings, and the amendments to the Memorandum of Association (MOA) and the Rules of NIEPA are being drafted. As and when the amendments are carried out, the same would be put up in the subsequent Academic Council meeting.

Agenda item No. 21.3.5 Signing of MOU with Ministry of Human Resource Development

The Vice-Chancellor informed the Council that the MoU has been finalised through a democratic process as per the template supplied by MHRD and sent to MHRD vide letter dated 16/1/2018 for further necessary action. He also briefed the members that NIEPA has been asked to raise 30 percent resources, for which NIEPA has raised its concerns on difficulties being faced in mobilizing the additional resources, and is negotiating the process.

The Academic Council members also supported the stance of NIEPA, and felt that given the circumstances and the mandate of NIEPA, it is difficult for NIEPA to mobilise resources.

Agenda item No. 21.4 Ratification of action taken regarding UGC letter No.F.5-1/2017 (CPP-I/DU) dated 10th November, 2017 on use of the word "University" by Institutions Deemed to be Universities as per the Direction of Hon'ble Supreme Court.

The Vice-chancellor informed the Council that in compliance with the directions of the Hon'ble Supreme Court, the word 'University' in the name - National University of Educational Planning and Administration (NUEPA) has been replaced by the word 'Institute' and now it is being called as National Institute of Educational Planning and Administration (NIEPA), which will continue to be a deemed to be University.

Agenda item No. 21.5 Registration of Topics of Ph.D. Thesis and M.Phil Dissertations of the Scholars admitted in 2016

Agenda Item No.22.3.5 New Admissions: M.Phil. and Ph.D. Courses for the year 2018-19

The Vice-Chancellor briefed the Council that the University has issued an advertisement inviting applications for M.Phil./Ph.D. Admissions for the year 2018-19 and the details of the same have been uploaded on the website. He also mentioned that the written test has been scheduled for 23rd June, 2018 and the personal interviews will be held on 25th & 26th June, 2018.



The Vice-Chancellor also briefed the members that the selection process for the M.Phil and Ph.D programmes, which currently are independent programmes, is under review to make it into an integrated programme. He also informed the Council that the curriculum for the M.Phil/Ph.D programme course work is also being revised and will be reported in the next Academic Council meeting.

Agenda Item No. 22.4 Considering approval of the Training Programmes for the year 2018-19

The Vice-chancellor briefed the Council that NIEPA gathers information from stakeholders for formulation of training/seminars/workshops/ programmes in the ensuing year. Accordingly based on the proposals received from the stakeholders including State Governments and after due deliberations with concerned departments and faculty members at NIEPA, a total of 127 training/seminars/workshops/ programmes have been proposed for the year 2018-19.

The council noted the information with satisfaction and approved the proposed training programmes for the year 2018-19.

Agenda Item No. 22.5 Considering proposals for proposed Research Studies during the year 2018-19

The Vice-Chancellor briefed the Council that conducting research in the areas related to educational planning and administration at NIEPA is one of its key areas of focus. It was informed that 21new research studies have been proposed by the faculty members. He also informed the members that these proposals are not yet finalized and will be further refined based on inputs from experts.

The Council suggested that a brief outline of department-wise mandate based on the Institute's mandate be given along with the main purpose and

It was also mentioned that a faculty member is expected to start a new research project only after completing his/her pending research projects.

It was also suggested that the date of joining of the project staff should be considered as the date of launch of a project, and this will be managed and coordinated by the Project Management Unit (PMU).

It was also mentioned that an extension to a research project will be given only after the review of the expert committee.

After due deliberations, the Council approved the proposed research studies.
