

ORDER


- (a) The appellant has filed first appeal No. NUEPA/A/E/25/00003 dated 29.04.2025 Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. RTI No. NUEPA/R/E/25/00033 dated: 28.03.2025 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the NIEPA.
- (b) The submission in the RTI Appeal is "Provided incomplete, Misleading or False Information".
- (c) The Appellant has informed in the instance appeal that "(i) Regarding Question No.1.the Information provided appears to be incomplete. I kindly request you to furnish the score obtained by all candidates in both paper I and Paper II. In this context, I would also like to refer to the information of the Hon'ble Supreme Court of India in Civil Appeal No(s). 2783/2025, which upholds the right to such information under the RTI Act. A copy of the judgement is enclosed for your reference. 2 Regarding Question No. 02, the information provided appears to be incomplete. I kindly request you to furnish the Answer Key of Paper I and Paper II also. Your kind cooperation in this matter is appreciated."
- (d) The appellant vide email dated April 30, 2025 was informed to appear for hearing in the Office of the FAA on 09.05.2025.
- (e) The appellant in response to the email requested for online hearing which was duly accepted by FAA.
- (f) The reply of the Respondent (CPIO) in the instant appeal is as under:
1. It is submitted that the information sought by the Applicant (Appellant here in after) in response to his RTI Application No. NUEPA/R/E/25/00003 dated: 29.04.2025 was duly replied.



- (g) This office has carefully considered the application, the response, the appeal and the records made available and the matter was decided based on the material available on record.
- (h) The FAA agreed to the submissions made by the CPIO. However, CPIO is further directed to kindly get the following information uploaded on the website of NIEPA within 30 days of the receipt of this order.
- The scores obtained by all candidates by application number-wise; and
