ORDER

- (a) The Appellant has filed first appeal on 07/08/2024 Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. RTI Reg.No.NUEPA/A/E/24/00015 dated 03.07.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the NIEPA.
- (b) The appellant vide his email dated 16th August, 2024 has requested for online hearing with FAA.
- (c) The Appellant vide his application dated 07-08-24 has requested to provide the information.
- (d) The Appellant has informed in the instant appeals that "details not provided."
- (e) The reply of the Respondent against the instant appeal is as under: -
 - 1. It is submitted that the information sought by the Applicant (Appellant hereinafter) on 07.08.2024 (Copy enclosed) in response to his RTI Application No. NUEPA/R/E/24/00015 dated 03.07.2024 was of third party and the same was denied under the Right to Information Act, 2005.
 - 2. The contents as above made in the RTI reply stands as it is and are candid".
- (f) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

- (g) The office directs the CPIO to act as per Section 11 of the act, which provides the procedure of disclosure of third-party information.
- (h) The instant case is not similar to the matter referred by the appellant in his appeal by quoting the Hon'ble Karnataka High Court order in Writ Petition No. 23695 of 2022 (GM-RES), as the third party never sought for lien in joining the present employment.

The appeal is accordingly disposed of.
