2. **Method of Recruitment:**

The method of Recruitment will be **Written Test/Skill Test/Interaction.** The exact details shall be communicated through email/Institute's website.

3. **General Terms & Conditions**

1. Only Indian Nationals are eligible to apply.
2. Candidates applying for the reserved post must ensure that they are entitled for such reservation as per the eligibility prescribed. They should also be in possession of the necessary caste certificate in support of their claim at the time of filling up of application form.
3. All educational, professional and technical qualification should be from a recognized Board/University.
4. Persons working in Govt./PSUs/Autonomous Bodies should apply through proper channel or produce a relevant 'No Objection Certificate' at the time of Written Test/Skill Test barring which their candidature will not be considered and will be treated as cancelled.
5. The candidates are required to satisfy themselves before applying that they possess the essential qualifications laid down for the post.
6. No modifications are allowed after candidate submits the online application form including category. If any discrepancies are found between the data filled by the candidate online and the original testimonials, his/her candidature is liable to be rejected. Hence, no request for change in any particulars of any candidate shall be entertained by the Institute at a later stage.
7. The prescribed essential qualifications are the minimum and the possession of the same does not entitle candidates to be called for Written/Skill Test etc.
8. In case, a large number of applications are received, screening will be done to limit the number of candidates to those possessing higher/relevant qualification and experience.
9. Closing date of Online Application will be the CRUCIAL DATE for determining the eligibility with regard to age, essential qualification etc.
10. Only shortlisted candidates will be called for Written Test/Skill Test etc.
